Course description and objectives

The aim of this course is twofold:

- to provide an insight into current international and interdisciplinary research and thinking on CSR and the law; the reading provided is based on a wide range of academic articles from a variety of countries and disciplines.
- to develop <u>research and theoretical skills</u> by reading and analysing international research material.

Prerequisites

Undergraduate training in law and/or business

Learning outcomes

Students taking this course will gain specific knowledge regarding both the legal regulation of CSR and the influence of CSR on the law. The focus will not be confined to French law but explore issues raised in international law, EU law and common law jurisdictions. Students will be expected to read and research broadly to build their own perspective on complex issues.

Assignments and grading

I) IN-CLASS ORAL ASSESSMENT 50% of your final grade

II) END OF TERM EXAM 50% of your final grade
